The purpose of this course is to introduce students to multilevel governance (MLG); that is, public decision-making which involves governments at various levels and non-governmental agents as well. We are interested in the forces conducive to this kind of decision-making structure, and in the general patterns and dynamics that it manifests. We will consider all levels of government, and cases from Canada, the United States, Europe (EU) and perhaps Australia.

Evaluation

Each student will make one class presentation related to the topics below (10%) and will submit a written report one week later (20%). A research paper on a different topic (50%) must be submitted by December 14 at the latest. Students will also be graded on the quantity and quality of class participation (20%).
