### What This Course is About

On 24 February 2022 Russia escalated and launched a full-scale war against Ukraine. This non-essay course with no pre-requisites gets behind the headlines and explores the what, why, and how of this brutal, unprovoked war in modern Europe. Themes include hybrid warfare, disinformation, geo-politics, international law, humanitarian impact, and more.

### **How This Course is Structured**

This online course is offered online asynchronously which means that our OWL site will be our virtual classroom and we will not be meeting in person. Please familiarize yourself with the course site. Every week students will be expected to complete the required readings then view the lecture videos which will include guest lecturers and afterwards to complete a short quiz. The lecture videos will be posted weekly, at noon every Wednesday, and students can view them at their convenience. There will be a mid-term test and a final exam. Both will be online and students will have a one week window in which to complete them.

### What Students Need to Do

- Complete the assigned weekly required readings and take individual notes
- Watch the weekly lecture videos and take individual notes
- Complete the weekly quiz, each one is worth 3% of the final mark
- Complete the mid-term test worth 30% of the final mark
- Complete the final exam worth 40% of the final mark

### What Students Will Learn

This course is designed to increase student knowledge and skills. At the end of this course students will understand the details of Russia's 21<sup>st</sup> century war against Ukraine, the larger geo-political and historical context and its international implications including Canada's role. Equally importantly students will improve their media literacy and critical analysis skills through our discussions about information warfare, competing narratives and how to weed through the disinformation that continues to cloud these events.

### **How Students Will Be Evaluated**

1.	Weekly quiz, each worth 3%	30%
2.	Mid-term test, Week 7 (multiple choice)	30%
3.	Final Exam, Exam period (multiple choice)	40%

Every week there will be a short quiz based on the material from the required readings and lecture videos. The quizzes will be on the OWL site in the Tests and Quizzes section. Each quiz will have 3 short questions, each correct answer worth 1%, for a possible total of 3% per quiz. There will be a total of 10 quizzes, for a total of 30% of the final mark. In week 7 there will be an online mid term test, the format will be multiple choice, it will be worth 30% of your final mark and will be on the Tests and Quizzes Tab. There will be a Final Exam also online and multiple choice format. For both the Mid Term Test and the Final Exam students will have a one week window in which to complete the 2 hour test/exam.

## **Readings and Additional Materials**

Each week there will be 1 or 2 articles which students will be required to read. These readings will be available online, although some of the articles which are not available open access will need to be accessed through the university library catalogue. Students will also be provided with suggested further readings and materials, for anyone who would like to learn more about any topic. These are optional and students will not be tested on the content of the suggested readings/materials.

## APPENDIX TO UNDERGRADUATE COURSE OUTLINES DEPARTMENT OF POLITICAL SCIENCE

### Prerequisite checking - the student's responsibility

"Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites."

### **Essay course requirements**

With the exception of 1000-level courses, most courses in the Department of Political Science are essay courses. Total written assignments (excluding examinations) will be at least 3,000 words in Politics 1020E, at least 5,000 words in a full course numbered 2000 or above, and at least 2,500 words in a half course numbered 2000 or above.

### **Use of Personal Response Systems ("Clickers")**

"Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

- the use of somebody else's clicker in class constitutes a scholastic offence,
- the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence."

#### **PLAGIARISM\***

In writing scholarly papers, you must keep firmly in mind the need to avoid plagiarism. Plagiarism is the unacknowledged borrowing of another writer's words or ideas. Different forms of writing require different types of acknowledgement. The following rules pertain to the acknowledgements necessary in academic papers.

## A. In using another writer's words, you must both place the words in quotation marks and acknowledge that the words are those of another writer.

You are plagiarizing if you use a sequence of words, a sentence or a paragraph taken from other writers without acknowledging them to be theirs. Acknowledgement is indicated either by (1) mentioning the author and work from which the words are borrowed in the text of your paper; or by (2) placing a footnote number at the end of the quotation in your text, and including a correspondingly numbered footnote at the bottom of the page (or in a separate reference section at the end of your essay). This footnote should indicate author, title of the work, place and date of publication, and page number.

Method (2) given above is usually preferable for academic essays because it provides the reader with more information about your sources and leaves your text uncluttered with parenthetical and tangential references. In either case words taken from another author must be enclosed in quotation marks or set off from your text by single spacing and indentation in such a way that they cannot be mistaken for your own words. Note that you cannot avoid indicating quotation simply by changing a word or phrase in a sentence or paragraph which is not your own.

### B. In adopting other writers' ideas, you must acknowledge that they are theirs.

You are plagiarizing if you adopt, summarize, or paraphrase other writers' trains of argument, ideas or sequences of ideas without acknowledging their authorship according to the method of acknowledgement given in 'A' above. Since the words are your own, they need not be enclosed in quotation marks. Be certain, however, that the words you use are entirely your own; where you must use words or phrases from your source, these should be enclosed in quotation marks, as in 'A' above.

Clearly, it is possible for you to formulate arguments or ideas independently of another writer who hasexpounded the same ideas, and whom you have not read. Where you got your ideas is the important consideration here. Do not be afraid to present an argument or idea without acknowledgement to another writer, if you have arrived at it entirely independently. Acknowledge it if you have derived it from a source outsideyour own thinking on the subject.

In short, use of acknowledgements and, when necessary, quotation marks is necessary to distinguish clearly between what is yours and what is not. Since the rules have been explained to you, if you fail to make this distinction your instructor very likely will do so for you, and they will be forced to regard your omission as intentional literary theft. Plagiarism is a serious offence which may result in a student's receiving an 'F' in acourse or, in extreme cases in their suspension from the University.
