**Course Description** 

In the 2010s the argument was made that '21st-century wars would be different compared to wars of the past'. How far is this argument true? In what ways will 21st-century warfare be different? Will warfare be more or less frequent? Will wars be more or less significant or consequential as events? Will the reasons for going to war be different? What will be the impact of new weapons and techniques of warfare, such as killer robots and cyberwarfare? How will the laws of war be affected by this? To examine these questions, we will read theorists representing the schools of Realism, Liberalism, Feminism, Marxism, Civilizationism and Post-modernism.

#### **Learning Objectives**

By the end of the course, students should

- a) be able to describe and evaluate six different theories of international relations;
- b) be able to discuss questions regarding war in the 21st century; and c) have improved their essay-writing skills.

Essays: 3000 words (not including bibliography or footnotes); typed; double-spaced; you must keep a copy for yourself and you must keep your notes and rough drafts; if you make a reference to or quote from the internet, you must print the page cited, highlight the quote, and include it with the essay as an appendix. Include page numbers with every non-internet reference. Include a title page—please include your e-mail address on the title-page. Submit a paper copy at the beginning of class on the due date. After the beginning of class the essay will be considered late. Also submit an electronic copy (without the appendix) at OWL in the Assignments file by the beginning of class on the due date. Essay Topics: Note: you must submit an essay proposal!

- 1. Choose a 21st-century conflict involving two states (e.g. Russia and Ukraine). How would one of the theorists explain and evaluate this conflict?
- 2. Choose a 21st-century conflict involving a state and an international substate group. How would one of the theorists explain and evaluate this conflict?
- 3. How will ONE of the following new innovations affect war in the 21st-century? How would ONE of the theorists evaluate the effects of this innovation?
- A) Transhumanism.
- B) Killer Robots/Autonomous machines
- C) Private Military Companies
- D) Cyberwar
- E) Space (as a new area or 'theater' of combat)

Essay Proposal: You must submit an essay proposal on the sheet provided below during a meeting with me at my office on February 7th or 8th. A sign-up sheet will posted on my office door on January 18th. You are welcome to consult me earlier.

We will discuss your proposal, and I may ask you to make changes. Your mark will be applied to the 'final' proposal. The final draft must be submitted by 3 pm on Feb 16th.

You should arrive for your appointment having decided on the issue which interests you, and be able to discuss the issue with some familiarity. You will also list one good secondary source (book or academic article) which lays out the facts related to the issue (including defining key terms). Lastly, you will list the theorist you will use to examine the issue. The secondary source will *not* mention your theorist in regard to the problem. You do not need a thesis/answer to the question at this point. I want you to discover your answer after applying your theorist's ideas.

Please note that I will reject topics with 'obvious' answers: e.g. whether Gray thought that war would continue in the 21st century. Late Proposals: the late penalty for essay proposals is 20% per day from your scheduled appointment on the 7th or 8th. Contact me if your proposal will be late.

Essays: All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. #### APPENDIX TO UNDERGRADUATE COURSE OUTLINES DEPARTMENT OF POLITICAL SCIENCE

Prerequisite checking - the student's responsibility

"Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites."

Essay course requirements

With the exception of 1000-level courses, most courses in the Department of Political Science are essay courses. Total written assignments (excluding examinations) will be at least 3,000 words in Politics 1020E, at least 5,000 words in a full course numbered 2000 or above, and at least 2,500 words in a half course numbered 2000 or above.

Use of Personal Response Systems ("Clickers")

"Personal Response Systems ("clickers") may be used in some classes. If clickers are to be used in a class, it is the responsibility of the student to ensure that the device is activated and functional. Students must see their instructor if they have any concerns about whether the clicker is malfunctioning. Students must use only their own clicker. If clicker records are used to compute a portion of the course grade:

• the use of somebody else's clicker in class constitutes a scholastic offence,

• the possession of a clicker belonging to another student will be interpreted as an attempt to commit a scholastic offence."

#### **PLAGIARISM\***

In writing scholarly papers, you must keep firmly in mind the need to avoid plagiarism. Plagiarism is the unacknowledged borrowing of another writer's words or ideas. Different forms of writing require different types of acknowledgement. The following rules pertain to the acknowledgements necessary in academic papers.

A. In using another writer's words, you must both place the words in quotation marks and acknowledge that the words are those of another writer.

You are plagiarizing if you use a sequence of words, a sentence or a paragraph taken from other writers without acknowledging them to be theirs. Acknowledgement is indicated either by (1) mentioning the author and work from which the words are borrowed in the text of your paper; or by (2) placing a footnote number at the end of the quotation in your text, and including a correspondingly numbered footnote at the bottom of the page (or in a separate reference section at the end of your essay). This footnote should indicate author, title of the work, place and date of publication, and page number.

Method (2) given above is usually preferable for academic essays because it provides the reader with more information about your sources and leaves your text uncluttered with parenthetical and tangential references. In either case words taken from another author must be enclosed in quotation marks or set off from your text by single spacing and indentation in such a way that they cannot be mistaken for your own words. Note that you cannot avoid indicating quotation simply by changing a word or phrase in a sentence or paragraph which is not your own.

B. In adopting other writers' ideas, you must acknowledge that they are theirs.

You are plagiarizing if you adopt, summarize, or paraphrase other writers' trains of argument, ideas or sequences of ideas without acknowledging their authorship according to the method of acknowledgement given in 'A' above. Since the words are your own, they need not be enclosed in quotation marks. Be certain, however, that the words you use are entirely your own; where you must use words or phrases from your source, these should be enclosed in quotation marks, as in 'A' above.

Clearly, it is possible for you to formulate arguments or ideas independently of another writer who has expounded the same ideas, and whom you have not read. Where you got your ideas is the important consideration here. Do not be afraid to present an argument or idea without acknowledgement to another writer, if you have arrived at it entirely independently. Acknowledge it if you have derived it from a source outsideyour own thinking on the subject.

In short, use of acknowledgements and, when necessary, quotation marks is necessary to distinguish clearly between what is yours and what is not. Since the rules have been explained to you, if you fail to make this distinction your instructor very likely will do so for you, and they will be forced to regard your omission as intentional literary theft. Plagiarism is a serious offence which may result in a student's receiving an 'F' in acourse or, in extreme cases in their suspension from the University.
