#### **Curriculum Development/Teaching Innovations**

- Fall 2023. Created a new online, asynchronous course, POL 1030F: A Beginner's Guide to Canada.
- Fall 2023. Revamped the tutorials for POL 2530F so that each tutorial is now organized around an active learning pedagogy. Students work through problem-based activities, simulations, games, and structured group work designed to have students experience, reflect on, apply, and critically analyze materials introduced earlier in the week during the lecture.
- Fall 2020. Created a new course, POL 2530F: Foundations in Canadian Government & Politics. The course was redesigned to introduce students to how political scientists study Canadian Politics with a focus on major puzzles, theories, and data in the subfield. Students learn how to apply theory and to interpret a wide range of qualitative and quantitative data, with a special emphasis on having students read and work through regression tables and figures, while learning about rational choice, historical institutionalism, and other theories.
- Fall 2014. Worked with Teaching Support Services to make use of WLU's course management software (Desire-2-Learn) to measure student success in achieving program and course-level learning objectives in PO 263: Canadian Government and Politics.
- Fall 2014. Used the "flipped classroom" pedagogy to teach the unit on Canadian Federalism. Students watched a short video that I recorded and completed a textbook reading prior to coming to class. In class, students divided themselves into smaller groups where they had to redesign the Canadian division of powers to address the social cleavages of Canadian society. At the end of class, students presented their proposals and voted on which one best addressed Canada's

cleavages. They then had to reflect on the proposals by posting a short paragraph online on the course website.

- Fall 2013. Created short videos using an interactive whiteboard app (e.g. screen chomp; doceri; explain everything) that re-explains course concepts that at least two students have had trouble understanding (as measured by emails or visits during office hours). Students download and watch the video as many times as needed.
- Fall 2013. Used the "flipped classroom" pedagogy to teach the unit on "The Canadian Judiciary" in PO 263. For this class, students read a chapter from the course textbook, watch three interactive whiteboard videos on judicial decision making and judicial activism, and complete an online quiz on the readings and the videos. In class, I deliver a 5-10 minute lecture covering any material students had trouble with on the quiz. The rest of the three hour class involves students working in small groups applying course concepts to explaining a range of judicial scenarios. In-class assessments involve small and large group discussion, participating in learning catalytics questions, and writing a short group report to be posted on myls.
